The Great Developer King

by His Majesty the King and implemented throughout the country, most of them aimed at improving the living conditions of his subjects, especially those in the remote rural areas. All these development projects have originated from the frequent and extensive trips made by His Majesty, sometimes accompanied by Her Majesty Queen Sirikit and other members of the Royal Family, to all regions of the Kingdom. His Majesty has thus become not only the most travelled monarch in Thai history (and perhaps the monarch who has made the most working trips among rulers of the world today), but also the best informed about the whole spectrum of rural problems in Thailand.

His Majesty learns first-hand, from the people themselves, of the local conditions and problems. After having put them at their ease, he converses with the local inhabitants and learns from them the problems with which they are faced as they themselves perceive the situation. After consulting further with the officials concerned, His Majesty makes his own conclusions about the problems, including the causes and the possible methods to address them. Upon his return to Bangkok, or sometimes even on the spot, he will share what he has learned with the members of the Government, requesting them to assist and give support to the people wherever feasible. Sometimes he has used his own funds in the early stages to help a project get off the ground. In 1988, he established the Chaipattana Foundation to fund and help in accelerating rural development projects that are beneficial to the people and the country as a whole (more information on Chaipattana Foundation and its projects can be found at www.chaipat.or.th).

His Majesty never simply issue instructions and go it alone. The impetus always comes from the local people, who must agree with the proposal and cooperate to ensure its success. The "royally-suggested" or "royal-initiated" projects have all been started in this way. They cover a wide range of subjects from the introduction of new crops to water conservation, from swamp drainage to the preservation of forests, and their aim has been sustainable development, serving not only immediate needs, but also those of future generations. This is to be achieved by conserving the environment and restoring areas that have already suffered from misuse.

The Royal Development Projects are divided into eight categories according to the sector of the economy that is targeted viz: Agriculture, Environment, Public Health, Occupational Promotion, Water Resources, Communications, Public Welfare, and others (more details on Royal Development Projects can be found at www.rdpb.go.th).

In order to facilitate the implementation of the Royal Development Projects, His Majesty initiated the establishment of six Royal Development Study Centres, in various regions of the country to serve as the place for conducting study, research and experimentation in search of development guidelines and methods suitable to the different conditions of each area and the occupations of the local people. The results of such study, research and experimentation will be disseminated to the local people. The Centres are also intended to serve as "living natural museums" where interested people can come to observe and gain knowledge from the real thing. The Six Centres are located in Chiang Mai in the North, Chachoengsao, Phetchaburi and Chanthaburi in the Central Plain, Sakon Nakhon in the Northeast and

Narathiwat in the South. The achievements of His Majesty's life-long devotion and the Royal Projects have been highly acknowledged by numerous international institutions. In 1988 the Royal Project to Thailand has been selected to receive the Ramon Magsaysay Award for International Understanding. The Royal Project is recognized for demonstration through a concerted national and international effort in northern Thailand that temperate-climate cash crops offer hill tribes a viable alternative to the opium poppy. And in 2006, King Bhumibol was presented with UNDP's first (United Nations Development Programs) Lifetime Achievement Award for his life-long work advancing the lives of the rural poor in Thailand. With emphasis on sustainable water sources, conservation and flood and drought mitigation, His projects have benefited millions of people in rural areas of Thailand. It is this life-long devotion that has endeared him to all Thai people and has earned him the informal title "The People's King"

Today, His Majesty is not just the Head of State, he has also become a key factor in the development of the country. One of the best-known development theories suggested by His Majesty is "the New Theory". Introduced many years ago, the

New Theory involves land management and the development of water sources for agricultural purpose. Its formula is 30-30-30-10. Under the New Theory, a plot of land is divided into four portions, namely 30 percent for a water source, 30 percent for a rice field, 30 percent for mixed crops such as fruit trees and vegetables and 10 percent for residence, animal farms and rice barns. The New Theory has several advantages. It is uncomplicated, easily implemented, and does not involve costly technology. It has been tried and tested, and has produced satisfactory results. Farmers who have followed this theory have become selfsufficient and self-reliant.

All Thais come to understand the word "self-sufficient" after His Majesty the king suggested a development philosophy of self-sufficient economy or "sufficiency economy" as a way to pull Thailand out of the economic crisis that erupted in 1997. His Majesty the King's suggestion on the self-sufficient economy aims to encourage people to help themselves and strengthen communities through public participation. The idea places emphasis on basic economic development to be carried out step by step. People will greatly benefit from the development process, which is set to respond to their immediate economic demands and enable them to get through the crisis. Today, His Majesty's initiatives and extraordinary achievements have become imperative ramparts for Thailand's flourishing socioeconomy; thereby, underpinning Thailand's status as one of the countries with strongest economic performances in the region.





The Philosophy of Sufficiency Economy and Policy-making

"Sufficiency is moderation. If one is moderate in one's desires, one will have less craving. If one has less craving, one will take less advantage of others. If all nations hold this concept of moderation, without being extreme or insatiable in one's desires world will be a happier place."

– Royal Speech delivered on December 4 1998 By His Majesty, King Bhumibol Adulyadej of Thailand.

Over the past three decades, the philosophy of sufficiency economy has been developed and advanced by His Majesty King Bhumipol based on His Majesty's experiences in rural development throughout Thailand. After the economic crisis in 1997, His Majesty reiterated and expanded on the philosophy in numerous remarks, in particular during 1997 and 1998. Since then, Thai policy-makers have adopted the philosophy of sufficiency as a moral, ethical and practical compass, guiding their judgment in developing policies.

Since 1997, the Thai government has applied the elements of sufficiency economy philosophy to their socio-economic policies at varying degrees. It has adopted the philosophy of sufficiency economy as the bedrock of socio-economic policies, emphasizing moderation in economic management so as not to grow or expand beyond capacity, which could result in economic excesses or bubbles. Also, it stresses the importance of self-immunity and introducing proper risk management systems as well as good governance in order to safeguard economic stability.

A relevant indicator showing the implementation of His Majesty's philosophy of sufficiency economy as guidance of the national policy has been the National Economic and Social Development Plan, comprising ten plans divided into different periods, which have paved the way towards Thailand's economic and social development. The latest plan (10th plan covering 2007-2011) relentlessly deepens the methodology of sufficiency economy coupled with the openness to global economics, and international society. Suffice to say that in the light of Thailand's outstanding economic statistics, the sufficiency economy philosophy, since its commencement, has been proven to be an efficient and effective means to counteract the crisis and to establish a strong socio-economic foundation for the country in keeping up with globalization, building resilience in all sectors and harnessing opportunities of the global changes today and in the years to come.



Sharing Thailand experiences by a Friend of Thailand

Mr. Ulysses J. Lustria Jr. is one of the participants of the Buakaew Roundtable International 2010 Program held in 1-8 August 2010 in Thailand. The Buakaew Roundtable International 2010 is a study visit conducted by the Thailand International Development Cooperation Agency (TICA), to show and share Thailand's development experiences and best practices in various fields such as agriculture, public health and community development, in particular best practices of the Philosophy of sufficiency economy on food security, alternative energy and environmental conservation. In addition, the program aims to build cultural connectivity, strengthen relationships and establish technical cooperation between Thailand and ASEAN member countries, Timor-Leste, Mongolia and the Pacific Islands.

Philippines. Below are excerpts from his statement

We gained learnings from the experiences of Thailand in agricultural development as well as in alternative energy and environmental conservation. We gained learnings on sufficiency economy and got to see possible applications in our countries. Further, we were able to establish networks among the participants, the host agency, and also the ORDPB, and see possible future collaborations.

We are now aware and are appreciative of the meaning of rationality, moderation, immunity as well as ethics and knowledge. This was enhanced

One area that the Philippines can learn more from Thailand is agricultural processing as well as product standards. A Philippine Department



many places in the Philippines, Good Agricultural marketing system to ensure steady supply and Practice (GAP) has been just advocated, but has not been adopted. Thailand's processed products have already made inroads in the export market due to good packaging and product standards. In Thailand, only farms who adopt GAP are encouraged to export commodities. There are 300 inspectors and 7,000 advisors for GAP extension.

Another area is agricultural marketing. The study mentioned further that in the Philippines 1) there are no real wholesale markets but wholesale-retail markets, 2) both local and national terminal markets are congested and internal price negotiation is the prevalent practice inside the market, and 3) many players do their business on multi-layer marketing channel and take a lot of intermediate margin.

In contrast, Thailand can steadily supply different kinds of good quality products to supermarkets and other institutional buyers with the presence of 1) wholesale markets, 2) efficient contract farming has been established to ensure the delivery of reliable supply chain of high value commodities through organized production groups in many countries, and 3) suitable

extend them to many places.

One specific area is the development of the fruits industry, both fresh and processed. The Philippines has large companies but there are many small producers. There are many areas for improvement along the fruit supply chain, from production to marketing. Thailand is very strong in the fruits industry and may provide technical assistance to the Philippines.

A big area for collaboration is climate change adaptation as well as green technology development. The Philippines is now the preferred investment destination in Asia based on rising private investments in agriculture mainly for biofuel feedstock. Further, the Biofuels Act in the country and the rising awareness for the need to shift to clean fuel sources has provided the necessary stimulus for the development of the biofuel feedstock industry (Department of Agriculture, 2010).

With these learnings, we request that the Thailand Government help us in promoting the Sufficiency Economy approach in our respective countries. And we hope that more collaborative activities and projects will be implemented." -


